This letter is to inform you, that we have received an IPRA (Inspection of Public Records Act) request from Mr. Irvin Lindemuth. Mr. Lindemuth has requested that we send him your personal contact information, to specifically “ . . .include the Brazos address, billing address, phone numbers, and e-mail addresses.”

Under New Mexico State Law we are required to provide this information, and we wanted you to be made aware of Mr. Lindemuth’s request. Any member can make these requests under the IPRA. Nonetheless, we are required to provide Mr. Lindemuth with the information we have, and a hard copy of that information will be provided.
